

AZV BUSINESS CONDITIONS FOR PARTICIPATION OF EXHIBITORS

Conditions of participation

1. Delivery of Binding application to the address of Association of Organization of Gardening Exhibitions (hereafter AZV) and payment of an advance invoice for the registration fee and for rent of the ordered area. The due term will be stated in the invoice. When the payment is brought to account of AZV, the exhibitor will be properly registered. By this moment a contractual relation arises between the exhibitor and AZV.
2. In exceptional cases and when it is discussed in advance with the exhibitor, the organizer has the right to modify the area size and shape.
3. Condition to start assembly of the exhibition will be invoice payment, and that until 1st August 2012.

Payment conditions

1. The price of registration payment and area rental includes:
 - rental for area in the time from 30.08.2012, 08:00 to 02.09.2012, 12:00 (and stand liquidation on 02.09.2012 to be notified in advance)
 - ID cards for exhibitor (for each 10m² 1 piece free)
2. Other individually ordered services have to be paid until 1th August 2012.
3. Conditions for cancellation of participation:
 - if the Binding application is cancelled until 15th August 2012, 30% of the advance payment is not paid back.
 - if it is cancelled between 15nd August 2012 and beginning of the fair, then 100% of the advance payment for area rental, including registration payment
4. All prices quoted in the price list are the final prices. AZV is a VAT payer. The final invoice, together with subtraction of advance payments, will be sent by the organizer within 14 days after the fair finish.
5. All additional orders and changes announced and implemented between August 30, 2012 and the end of the fair will be charged with additional 50% of the price.

Technical conditions

1. The fair will start 31.08.2012 at 9.30 o'clock, finish 01.09.2012 at 17 o'clock.
2. Assembly of exhibitions from 30.08.2012 from 8 to 22 o'clock.
3. Disassembly of exhibitions 01.09.2012 17 to 21 o'clock or 02.09.2012 from 8 to 12 o'clock.
4. The fair will be opened for exhibitors daily from 8 to 20 o'clock.
5. To order and after prior consultation, the organizer provides at Veletrhy Brno corporation power supply, construction of exhibitions, equipment lending, technical material, service of a forklift for loading and downloading of exhibits – see Binding order Green World and order of services and equipment.
6. A lessor of the business premises (Veletrhy Brno corporation) provides at his cost insurance against natural disasters and damages caused by water delivery. He is not responsible for loss, destruction or any damage of their equipment (goods, packaging, things taken off etc.), without regard to the fact if destruction or other damage occurred before start, during or after end of rental of a non-residential area.
7. On request, the organizer will mediate an accommodation reservation for exhibitors.
8. The exhibitor is obligated to return the exhibition area to the organizer in the state, in which he took it over from the organizer, in the set term.
9. To assure tidiness in the fair area, containers free of charge for waste will be available.

Insurance

The organizer is not responsible to exhibitors for loss or any damage of their property during preparation, time of duration or liquidation and transport of exhibitions. The exhibitors are obligated to have their all property insured, if there is any risk of loss or damage – see Organization directions for assembly and disassembly of Veletrhy Brno corporation – Insurance.
